

Also includes a complete brand refresh (with photos and videos) plus design and build of new website, purchase of a new URL, and all additional necessary tech tools - like new CRM with customization and underlying software.

Star Fellowship. Semester-long congressional fellowship for 14 college women. Star Fellows are placed in internships with Congresswomen and receive weekly training on how to run for office, plus complimentary housing on Capitol Hill and a living stipend.

Young Women's Political Leadership Program. Weeklong training for 75 high school girls in Washington, DC. Attendees learn from hundreds of speakers, trainers and mentors, meet with their Members of Congress, and participate in a weeklong campaign simulation in teams.

Elect Her. Daylong training for college women on how to run for student government and beyond. Elect Her trainings are held on 50+ campuses around the country each year and feature a local elected woman and a member of student government.

Other Events (including Campus Women Lead). Running Start hosts a wide variety of one-off training events throughout the year. The largest in 2017 was Campus Women Lead (which was created with National Campus Leadership Council) and brought together 85+ college women student body presidents and candidates for student body president to teach them how to run for public office. Just 25% of top universities have women student body presidents (about the same percentage of Members of Congress and state legislators that are women).
