Running Start is a nonpartisan nonprofit that trains young women to run for political office. In 2016 Running Start continued with its core high school program, the Young Women's Political Leadership Program, its Capitol Hill program, the Star Fellowship, its in office-Internship program, competition for alums, Run with Running Start. Running Start also took sole ownership of the Elect Her program, which was developed in partnership with the American Association of Univeristy Women, and hosted summits at both 2016 national political conventions.

Star Fellowship  
The Star Fellowship is the only fellowship program specifically for college women on Capitol Hill. Each year, fourteen Star Fellows are competitively selected to work in the office of their favorite Congresswoman. Star Fellows receive weekly trainings on how to run for office and have the opportunity to expand their networks and receive one-on-one mentoring. Since 2009, Running Start has placed almost 100 Star Fellows in the offices of more than half of the women in Congress. Star Fellows receive free housing on Capitol Hill and a stipend.

Summits at the National Political Conventions  
Running Start hosted Summits at the 2016 Democratic and Republican National Conventions. The Summits featured inspirational women in politics and gave attendees the chace to learn practical tips for how and why they should run for office. The Summits were held in partnership with two other nonpartisan women in politics organizations, She Should Run and All in Together. Atlantic Media produced the events. Atlantic Media estimated that about 1,000 women participated in the Summits and left with a renewed energy to get involved in politics and run for office.

Young Women's Political Leadership Program  
The Young Women's Political Leadership Program is a weeklong training in Washington, DC for 75 high school girls. Each summer, Running Start brings together the most politically active teenage women from around the country and teaches them to run for office. Young Women's Political Leadership attendees hear from 250+ speakers, trainers, and mentors throughout the week and meet one-on-one with their Member of Congress. Young women also spend the week in campaign groups practicing the hands-on skills they are learnig and competing in a campaign simulation. At graduation, the young women elect one candidate the winner.

Elect Her is a day-long training to teach college women to run for student government and future political office. Elect Her was developed with the American Association of University Women (AAUW). The trainings were held at 50 colleges and universities around the country. 90% of 2016 participants who reported running for student government after the program won and 100% of 2016 participants would recommend the program to their friends. In 2016, Running Start became the sole owner of the program, which had previously been a collaboration with AAUW.

Additional Events & Programs (Expenses: \$31,423, Revenue: \$0 )

In 2016, Running Start hosted interns in its own office who learned about running a nonprofit and also attended Running Start's other political leadership trainings. They also received additional career development opportunities, including mentorship and connections with Running Start's network. Running Start also ran a campaign simulation contest for its alums. Finalists in the contest competed at the Young Women to Watch Awards for audience votes. The winner became Running Start's first-ever #ILookLikeAPolitician Ambassador. Finally, Running Start held or participated in many speaking engagements and other small events throughout the year.
